ORDINANCE NUMBER 2, SERIES 2023**

**AN ORDINANCE ADOPTING THE WASTE MANAGEMENT PROGRAM
ASSESSMENT FOR THE CITY OF AUDUBON PARK, KENTUCKY FOR THE FISCAL
YEAR 2024 AND PROVIDING FOR THE COLLECTION OF SAME**

SPONSORED BY COUNCIL MEMBER ELYSE SHACKLETON

WHEREAS, sanitation and trash collection in the City of Audubon Park is provided by contract between the City of Audubon Park and a private vendor; and

WHEREAS, historical data provide a basis for estimating needs for extraordinary efforts by and for the City of Audubon Park occasioned by storm damage and other unforeseeable circumstances;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF AUDUBON PARK, KENTUCKY:

1. The Waste Management Program assessment for fiscal year 2024 is determined for once-weekly collection at each category of residence and commercial facility as follows:

This ordinance shall be effective with its passage, signing and publication as required by law.


