## **Special Council Meeting Minutes**

# August 15, 2022

The purpose of this meeting is to cover topics from the agenda, because it is not currently "feasible" for the City to provide meeting room conditions during a state-wide public health emergency demanding social distancing.

#### **Call to Order**

The mayor called the meeting to order at 7:02 PM.

### **Opening Public Comments**

Mayor Williams opened the floor for opening public comments, hearing none. The mayor gave the floor to the city's engineer.

### **Engineer's Report**

The engineer gave the update on the MSD project. He spoke about the 5 ways stop. He gave to two options. The first would be an island deflector and the estimated cost for this option is \$46K. The second option would be to do the concrete work and striping without the deflector and the estimated cost would be \$25K.

### **Financial Report**

The mayor noted the written reports and asked for a motion to approve the cash flow and budget to actual reports. Mayor asked for a motion to approve the cash flow report. Madeline Bozeman made a motion to approve the cash flow report. Elyse Shackleton seconded, and the motion passed unanimously.

### **Code Enforcement Report**

Mayor Williams noted the written report and gave the floor to Chief Laun.

#### **Police Report**

Mayor Williams noted the written report and gave the floor to Chief Laun.

#### **Forest Board Report**

Mayor did not receive a forest board report. The mayor did mention that the board did have a meeting and they hammered down the new tree planting locations project.

#### **Unfinished Business**

Mayor Williams presented the ARPA project schedule and gave all the updates on the projects. Mayor Williams suggested 4 projects be removed from the uncommitted list of projects. The 4 projects that he recommended were: Several Park/Natural Play Improvements, Remaining City Hall Improvements, Small Athletic Fields and Re-grading Oriole

Park. The councilors agreed to remove those 4 items from the list and also agreed on removing public works commercial salt spreader. There were comments about setting up a reserve line item in the budget for automotives. The new vehicle will not be used for off duty employment.

The mayor moved on with the second reading of an *Ordinance Amending the Code of Ordinance with Respect to Building Permits*. He gave the floor to Michael Hartman to execute the reading. Madeline Bozeman made a motion to approve the ordinance. Daniel Stephen seconded, and the motion passed with 5 in favor (Madeline Bozeman, Daniel Stephen, Elyse Shackleton, Andrew Klump, and Michael Hartman in favor) (Austin Schwenker absent).

### **New Business**

The mayor presented the July 18, 2022, meeting minutes for approval. Daniel Stephen made a motion to approve. Madeline Bozeman seconded, and the motion passed with 3 in favor (Daniel Stephen, Madeline Bozeman and Elyse Shackleton in favor) (Michael Hartman and Andrew Klump abstain) (Austin Schwenker absent).

The mayor presented an *Ordinance Amending the Code of Ordinance with Respect to Regular and Special or Emergency Meetings.* He asked Michael Hartman for the first reading and the first reading was executed.

Madeline Bozeman made a motion to adjourn. Elyse Shackleton seconded.
