In consideration of Permit No. \_\_\_\_\_ granted by the Legislative Body of the City of Audubon Park to the undersigned owner personally or through his or her Agent, the owner hereby agrees to pay all damages for personal injuries to anyone or damages to property or improvements on account of any excavation made in or any obstruction placed upon any street, road, sidewalk or other public space of the corporate area of the City of Audubon Park harmless against any and all loss damage on account of personal injuries or property damage. This permit does not include plumbing, electrical, or heating for which a separate permit must be reviewed and issued by Louisville Metro Inspections Licenses and Permits, Planning and Zoning, Board of Health, utility companies, and other agencies also having jurisdiction. Such permits will be issued when drawings and specifications in accordance with code are submitted at same time building permit is issued or later, if owner so elects- however, owner agrees hereby to take such permits and to assume all costs and liability for same. Applicant attests full adherence to the restrictions and requirements of all easements including utility easements. Applicant agrees to comply with the currently applicable edition of Louisville Metro Land Development Code and all requirements of zoning regulations and current building code including but not limited building setbacks. Any modifications especially structural and exterior from original permit must be re-submitted. Any person or entity in violation of the Code of Ordinances for the City of Audubon Park shall be fined not less than \$10.00 nor more than \$100.00 for each offense, plus court costs as may be imposed. Each days continued violation shall constitute a separate offense.
