Call to Order

The mayor called the meeting to order at 7:00 PM.

Roll Call

Opening Public Comments

Mayor opened the floor for opening public comments. Hearing none, he moved on to the agenda.

Financial Reports

Mayor Williams noted the written reports and asked for a motion to approve the cash flow report and to accept the Budget to Actual report until the audit is completed. Madeline Bozeman made a motion to approve the cash flow report and to accept the budget to actual report. Austin Schwenker seconded, and the motion passed unanimously.

Engineer's Report

Mayor Williams has met together with the engineer and MSD and have a plan together for Eagle Pass to get some curbs constructed near Hess Lane. They will also create a master plan for the city to help with drainage issues. There were some discussions about sidewalks.

The mayor offered the June 28, 2021, meeting minutes for approval and asked for a motion to approve. Madeline Bozeman made motion to approve. Austin Schwenker seconded. The motion passed with 5 in favor (Andrew Klump, Austin Schwenker, Elyse Shackleton, Daniel Stephen and Michael Hartman in favor) (Madeline Bozeman abstained)

New Business

Mayor Williams started a discussion about finding new revenue sources that doesn't involve raising taxes.

Mayor's Report

Mayor Williams started a archival project with the garden club. The garden club gave the City of Audubon Park \$500 which went toward the Video Kitchen digitizing 30 years of the garden clubs' materials and pictures.

Laura Kelty has prepared some records that are ready to be destroyed. The mayor has recommended the next priority sign project is stand-alone stop signs. There were lengthy discussions about archiving the city records.
