

Council Meeting Minutes

November 22, 2021

The City Council of Audubon Park held a special meeting on Monday, November 22, 2021, pursuant to KRS 61.823 and KRS 61.826. This meeting will be a video teleconference meeting. The purpose of the meeting was to cover the agenda and because it is not currently “feasible” for the City to provide meeting room conditions during a state-wide public health emergency demanding social distancing.

Call to Order

The mayor called the meeting to order at 7:04 PM.

Roll Call

Opening Public Comments

Mayor Williams opened the floor, hearing none moved on with the agenda.

Financial Report

Mayor Williams noted the written reports and asked for a motion to approve the financial reports for October. Austin Schwenker made a motion to approve. Madeline Bozeman seconded, and the motion passed unanimously.

Police and Code Enforcement Report

Chief Minniear noted the written reports.

Unfinished Business

Mayor Williams started with approving the meeting minutes for October 18, 2021. Madeline Bozeman made a motion to approve the minutes. Elyse Shackleton seconded, and the motion passed with 5 in favor (Madeline Bozeman, Elyse Shackleton, Michael Hartman, Andrew Klump and Austin Schwenker in favor) and 1 abstained (Daniel Stephen abstained).

New Business

Mayor Williams presented the replacement and removal of street sign plan for the councilors to review. The plan numbered each sign to be removed or replace. Mayor Williams asked for a resolution to remove eight of the street signs. Andrew Klump made a motion to remove 1,2,3,5,6,8,9 and 10. Michael Hartman seconded, and the motion passed unanimously.

The asked for a resolution to remove #4, relocate and replace #7 and #11, remove #12 and #13. Madeline Bozeman made a motion for the resolution. Austin Schwenker seconded, and the motion passed unanimously.

The mayor gave the floor Andrew Klump to present a plan for a biowales and bumpouts at the 5-way intersection. Andrew Klump presented several options to discuss.

The mayor presented Ordinance 6,2021 amending 92.05 Abatement Procedure and gave the floor to Madeline Bozeman. Madeline asked Austin to read the ordinance. Mr. Schwenker executed the reading. The mayor asked for a motion to approve the ordinance. Madeline Bozeman made a motion. Elyse Shackleton seconded. The floor was opened for discussion. No final decisions were made.

Mayor's Report

Mayor Williams started the conversation about the Holiday Decorating Contest.


Closing Public Comments
