The Mayor call the meeting to order at 7:06 PM.

Opening Public Comments

The Mayor hearing no comments moved to the next item on agenda.

Financial Report

Mayor Williams noted the August and September budget to actual reports and the cash flow report. He asked for a motion to approve the August budget to actual report and the cash flow reports. Austin Schwenker made a motion to approve. Madeline Bozeman seconded, and the floor was open for discussion. The discussion included questions online item 55200 Legal Affairs and Claims and Judgements payable, line item 6140-20 Equipment, adjusting 4425 Proceeds of Community Activities and the Highway Safety Grant. The motion to approve passed unanimously. The Mayor presented the September budget to actual and cash flow report for approval and asked for a motion to approve. Austin Schwenker made a motion to approve. Andrew Klump seconded, and the floor was open for discussion. The discussion included questions on the following line items; 5455-10 forest management, road fund on the cash flow report, 5500-00. The motion to approve passed with 5 in favor (Stephanie George, Brittney Gorter, Jennifer Kleier, Andrew Klump and Austin Schwenker in favor) (Madeline Bozeman nay).

The motion to approve the minutes with the corrections passed with 5 in favor (Madeline Bozeman, Andrew Klump, Austin Schwenker, Jennifer Kleier, Brittney Gorter in favor) (Stephanie George abstained).

Jennifer Kleier started the conversation about road repairs on Cardinal Drive/Nightingale. Mayor Williams has been talking to Pat Mulvihill about the paving on Nightingale. Ms. Kleier will send picture to show specific problems.

Austin Schwenker wants to revisit the ordinance addressing garages sizes and yard signs.

Andrew Klump questioned the variance process.

Mayor Williams reached out to the City of Louisville and other City Mayors regarding Halloween guidelines. He shared the information which came from the state. There were lengthy conversations. Residents will be provided state guidance regarding Halloween via a supplemental newsletter.
