City Council:

MAYOR'S MUSINGS

Folks, this spring has been a season to remember, before even the Triple Crown! We managed to adopt a balanced budget, despite late-breaking news of property assessment spikes and resulting appeals; anticipated losses from early-payment discounts; hikes; and insurance premium several other uncertainties. On balance, we should still be able to pursue the most urgent deferred maintenance and other initiatives in the budget proposal - but there are some hard choices ahead. We continue to look at alternative funding sources like those described in previous columns, and my May 15 budget message, and always welcome feedback and more new ideas. To recap, those on the table already include

- A levy, approved by public referendum, to establish and maintain a restricted fund for the ongoing maintenance of City parks.
- Establishment of non-profit corporations within City departments that could conduct voluntary taxdeductible fund-raising activities.
- A local-option property tax surcharge, approved by public referendum, to fund a specific project, and expire when the project is completed.
- Rental of City facilities for meetings, ceremonies, parties, etc.
- Intensive screening and pursuit of grant opportunities from public and private sources for eligible programs.
- Establishment of necessary accounts, and active screening of sources, to acquire needed equipment through government and commercial surplus disposal.

Most of these avenues are untried, and all have the disadvantage of taking a lot longer to get final results than direct budgeting. But some show real promise for the longer term, especially by engaging everybody in supporting the specific programs and projects they want, either by referendum or voluntary contribution. Please let me or your favorite Councilor know your thoughts and reactions, and other ideas we should be exploring. We look forward to hearing from you!

There are several internal projects under way that won't produce direct visible results around the City, but are essential to support the operations that do. Documentation and record-keeping are intensive and time-consuming, and because they're less visible are the easiest functions to fall behind, as our own situation has so clearly shown. But these are the functions that ultimately define the organization and its capacity to operate well. So you may not see up close, but hopefully will get the benefit of:

- Recodification of the City's ordinances. This is a complete retooling of the City Code to conform to changes in statutes, eliminate inconsistencies and conflicts, incorporate newer ordinances, and identify further areas of development.
- An updated and streamlined Council orientation packet of key references, resources and procedural guidance.
- A thoroughly revised City Employee Handbook, consolidating personnel policies and procedures, standards of conduct, classification and compensation, and work schedules and standards.
- City staff procedure guides for recurring functions, to permit consistent, predictable and reliable results from staff operations in all areas.

 A coherent records management system that meets state standards, and provides secure storage, access and retrieval of essential City working materials and archives.

There are a couple more big-ticket items on the horizon I hope you'll be thinking about:

- We should start our conversation soon on waste management, as we enter the third year of our current 3-year contract. What services are essential, how often, and at what cost? Should we keep a uniform scheme for every household, or seek an *à la carte* franchise deal that might add administrative costs, but allow everyone to pick their own services? We need to hear from you.
- The next state legislative session is already taking shape, with a number of small-city as well as general-interest items likely to need scrutiny: land use regulation, tax credits, historic preservation, annexation, tax reform, and others.

Finally (for now!), be sure and give a big thumbs-up when you see them to our most recently established group of heavy lifters, the Parks and Recreation Board. Laura Jones, Mike Lally, Amy Shelton, Mark Stephens and Daniel Steven put on a heck of a show at the inaugural *Forest Fest*, and have several more events and activities in the chute or on the drawing board – all aiming to be self-sustaining. They need to hear your thoughts and ideas too. This is gonna be a fun place. We are The Park!

Tips for Homeowners

- Keep doors in your home closed and locked, including your garage doors – even when you are working outside in your yard. An open door is an invitation.
- Be a good neighbor and alert police to any unusual activity in your neighborhood. Keep a check on your neighbors – especially your elderly neighbors. Keep a watchful eye out for any unusual activity or people in your neighborhood. If something looks suspicious – call the police dispatch (574-5471)! We are always glad to check it out!
- Plan for vacation by having your mail and newspapers stopped, or having a neighbor pick them up.
- Leave inside lights on timers to create the impression that your house is occupied. Be sure to set your alarm system. Have a lawn service or neighbor mow your lawn.
- Avoid home improvement scams and deception burglaries by taking a proactive approach. Be particularly alert to anyone in your neighborhood looking to perform home repair and asking to gain entry into your home. Ask to see identification and let them know you are going to call and get verification from their company before allowing them inside. If they are legitimate, they won't mind the wait.

Tips for Drivers

- Do not leave valuables or cash in your car. If you must leave items in the car, lock them in the trunk. If you have folding rear seats, make sure those are locked, too.
- Be alert for children playing in neighborhoods and residential areas. Young children may be more concerned about catching a ball that rolls into the street than watching for vehicles coming toward them.

 Drive safely and slowly around parks and playgrounds. More children are out playing during the summer.

Tips for Parents

- Provide a list of phone numbers of neighbors, family, and friends that your child can call in an emergency. Make sure your child knows how to dial 911, and when it is appropriate to do so.
- Know the route your child will take to and from a given location. Remind your child never to take a shortcut or deviate from the agreed-upon route.
- Establish rules for using the Internet. Children should have adult supervision when online. Make sure your child knows to never give out personal information on the Internet.
- Require your child to check in with a parent before leaving the house and when returning home. Teach your child that there is safety in numbers and that it is best to be with a group of friends when going places without an adult.
- Provide a bike helmet and require your child to wear it, as well as brightly colored or reflective clothing.

Brad Derrick City Engineer

Christopher Heaps Police Officer

Officer Chris Heaps served honorably in the United States Army from 1984 to 1991 as a Fire Control Instrument Technician. He went to "Inactive Reserve" status from 1991 to 1993, when he officially separated from service.

In 1991 Chris applied for the Louisville Police Department, and was hired in October of that year. Officer Heaps was a patrolman in 3 different divisions from 1991 to 1995. In 1995 he applied for the newly formed Gang Unit and was picked over a large number of officers who applied. He became regionally renowned as an expert in gang related matters.

Chris left the Gang Unit in 1995 to do another stint in patrol until 1999. In 1999 he transferred to the training unit where remained until his retirement. He is an official "Glock" and "Taser" armorer, and holds certifications to train officers in many different skills areas, (which will allow us to do "in-house: training – which will save the City of Audubon Park money). Officer Heaps is married with 3 daughters. We are proud to have Officer Heaps as the latest addition to the Audubon Park Police Department.

FRIENDLY REMINDERS

In addition to community calendars, event notices, meeting schedules, and official information, the entire City Code is available on the Web site, *AudubonParkKY.org*, with provisions on parking, permit requirements, nuisance abatement, and all the rest. Please visit often!

- There is no parking permitted on the street or on parking pads between 2 A.M. and 6 A.M. There is also no parking permitted on the grass. Please inform guests to your home of this important information.
- Building, tree, and property sale permits are issued through City Hall. If you have a project in mind, a tree you would like to trim or remove on the easement, or if you would just like to have a yard sale, please call or come by City Hall for more information on obtaining a permit.

Be Safe While Walking, Biking or Running

Please wear reflective clothing or other reflective gear – or, better still, carry powered lights – if you are out running, biking or walking in reduced light. It can be very difficult to see you if you are wearing dark clothing! Please take personal responsibility for this so accidents don't occur – you may be harder to see than you think!

- Report any streetlights that are out of order or malfunctioning to City Hall, at 637-5066. This input will be relayed to LG&E for repairs.
- Please discourage children and others from climbing trees in the various City parks, out of concern for both safety and potential damage.
- Information regarding ash trees and the emerald ash borer is available at City Hall, and on the Tree Committee's Web site, *TreeCommittee-APKY.org.*
- Trash collection days in the City are Tuesdays and Fridays. Recycling is collected on Tuesday, and yard waste on Friday. Garbage is picked up from behind your house both days, while yard waste and recycling items are to be placed at the curb. Be sure to report any missed collection to City Hall.
